**DISPUTE: CLAIM OF EMPLOYEES:**

1. That the Missouri Pacific Railroad Company is in violation of the current agreement by improperly assigning car-helper-oilers to inspect cars for defective brass, cut journals and waste grabs.

2. That accordingly, the Missouri Pacific Railroad Company be ordered to additionally compensate the following car inspectors in the amount of eight (8) hours per day at the time and one-half rate for the dates listed below and as long as this violation continues:
