STATEMENT OF CLAIM: Claim for and in behalf of Mitchell Davis and other employes similarly situated for certain amounts deducted from their wages in violation of paragraph "E" of Article One, and paragraph "B" of Article Four, of the Current Agreement. Further, that such payment be made retroactive to March 1, 1941.

FINDINGS: The Third Division of the Adjustment Board finds:

That the dispute was certified to the Third Division of the Adjustment Board ex parte by complainant party; and

That no hearing thereon has been held, and under date of December 18, 1944, the complainant party addressed a formal communication to the Secretary of the Third Division withdrawing this case, which request is hereby granted.

AWARD

Case dismissed.
