PARTIES TO DISPUTE:

BROTHERHOOD OF SLEEPING CAR PORTERS

THE PULLMAN COMPANY

STATEMENT OF CLAIM: * * * for and in behalf of C. R. Middlebrook who is now, and for a number of years past has been, employed by The Pullman Company as a porter operating out of the district of Jacksonville, Florida.

Because The Pullman Company did, under date of September 21, 1945, take disciplinary action against Porter Middlebrook by assessing his record with an actual suspension of eight (8) days; which action was unjust, unreasonable and in abuse of the Company's discretion.

And further, for the record of Porter Middlebrook to be cleared of the charge and for him to be reimbursed for the eight days wages lost as a result of this unjust and unreasonable disciplinary action.

OPINION OF BOARD: The evidence of record discloses no grounds for disturbing the action of the carrier.

FINDINGS: The Third Division of the Adjustment Board, after giving the parties to this dispute due notice of hearing thereon, and upon the whole record and all the evidence, finds and holds:

That the carrier and the employe involved in this dispute are respectively carrier and employe within the meaning of the Railway Labor Act, as approved June 21, 1934;

That this Division of the Adjustment Board has jurisdiction over the dispute involved herein; and

That the evidence of record discloses no grounds for disturbing the action of the carrier.

AWARD

Claim denied.
