### PARTIES TO DISPUTE:

## BROTHERHOOD OF SLEEPING CAR PORTERS

### THE PULLMAN COMPANY

STATEMENT OF CLAIM: \*\*\* for and in behalf of S. F. Balais who was formerly employed by The Pullman Company as an attendant operating out of the Chicago District Commissary.

Because The Pullman Company did, under date of Decmber 5, 1944, discharge Mr. Balais from his position as an attendant in the above mentioned district on charges unproved; which action was unjust, unreasonable and in abuse of the Company's discretion.

And further, for Mr. Balais to be reinstated to his former position as an attendant in the Chicago District Commissary with his seniority unimpaired and pay for time lost as a result of this unjust and unreasonable action.

OPINION OF BOARD: The evidence of record discloses no grounds for disturbing the action of the carrier.

FINDINGS: The Third Division of the Adjustment Board, after giving the parties to this dispute due notice of hearing thereon, and upon the whole record and all the evidence, finds and holds:

That the carrier and the employe involved in this dispute are respectively carrier and employe within the meaning of the Railway Labor Act, as approved June 21, 1934;

That this Division of the Adjustment Board has jurisdiction over the dispute involved herein; and

That the evidence of record discloses no grounds for disturbing the action of the carrier.

#### AWARD

Claim denied.
