**STATEMENT OF CLAIM:** Claim of the System Committee of the  
Brotherhood that:

(a) The Carrier violated the Clerks' Agreement at San Antonio, Texas,  
beginning August 1, 1945, when it used a Mail and Baggage Porter, on Sun-  
days and holidays only, to perform work regularly assigned to and performed  
by Messenger Howard Miller on all other days. Also

(b) Claim that Mr. Miller, or his successors, be paid eight (8) hours at  
the rate of time and one-half for each Sunday and holiday subsequent to  
August 1, 1945.

**FINDINGS:** The Third Division of the Adjustment Board finds:

That the dispute was certified to the Third Division of the Adjustment  
Board ex parte by complainant party; and

That no hearing thereon has been held, and under date of March 29,  
1947, the complainant party addressed a formal communication to the

Secretary of the Third Division requesting withdrawal of this case, which request is hereby granted.

AWARD

Case dismissed.
