**BROTHERHOOD OF RAILWAY AND STEAMSHIP CLERKS,
FREIGHT HANDLERS, EXPRESS AND STATION EMPLOYES**

CHICAGO AURORA AND ELGIN RAILWAY COMPANY

STATEMENT OF CLAIM: Claim of the System Committee of the Brotherhood that:

(a) Carrier violated provisions of Memorandum of Agreement dated Chicago, Illinois, March 10, 1951, by declining to allow wage compensation as therein provided for to employees who were in service on or after September 9, 1950, but for various reasons had left the service prior to January 29, 1951;

(b) That Elmer Seibert, Janitor at Wheaton, Illinois, P. W. Fortman, Storehouse Helper at Wheaton, Illinois, and Rudolph Hawlik, Janitor at Villa Park, Illinois, et al. # be allowed their wage loss, approximate \$381.99 \$342.78, and \$335.88 respectively, representing the difference between what they were paid for services performed for the Carrier from September 9, 1950 to the date their service was terminated and what they should have been paid under terms of the March 10, 1951 Agreement. #To include all other employees similarly affected, namely,
