STATEMENT OF CLAIM: Claim of the System Committee of the Brotherhood of Railway and Steamship Clerks, Freight Handlers, Express and Station Employes that the Carrier violated the rules of the current agreement,

- 1. When on November 1, 1954 it required certain employes in the Minneapolis Mail Room to suspend work to absorb the meal period in violation of Rule 32(a) of the current agreement covering employes of our craft and class.
- 2. That the Carrier now be required to compensate the following employes for one hour overtime daily effective November 1, 1954, and each and every day thereafter until the violation is discontinued:
