PARTIES TO DISPUTE:

THE ORDER OF RAILROAD TELEGRAPHERS

WESTERN MARYLAND RAILWAY COMPANY

STATEMENT OF CLAIM: Claim of the General Committee of The Order of Railroad Telegraphers on the Western Maryland Railway, that:

1. Carrier violated the Agreement when it caused, required or permitted train service employes, not covered by the Telegraphers' Agreement, to handle (receive, copy and deliver) train orders, at the time and place hereinbelow set out:

2. Carrier will be required to compensate the senior idle employe (extra employe preferred) Hagerstown Division, one day (8 hours) at the

minimum rate of \$1.9575 per hour, for each and every instance and date of violation as set forth above.

FINDINGS: The Third Division of the Adjustment Board finds:

That the dispute was certified to the Third Division of the Adjustment Board ex parte by the complainant party; and

That no hearing thereon has been held, and under date of February 28, 1957, the complainant party addressed a formal communication to the Secretary of the Third Division requesting withdrawal of this case, which request is hereby granted.

AWARD

Claim dismissed.
