**THE ORDER OF RAILROAD TELEGRAPHERS**  
**WESTERN MARYLAND RAILWAY COMPANY**

**STATEMENT OF CLAIM:** Claim of the General Committee of The Order of Railroad Telegraphers on the Western Maryland Railway, that:

1. Carrier violated the Agreement when it caused, required or permitted train service employees, not covered by the Telegraphers' Agreement, to handle (receive, copy, repeat and deliver) train orders, as follows:

3. Carrier will be required to compensate the senior idle employe (extra employes preferred) Hagerstown Division, for each violation set forth in Paragraphs 1 and 2, one day's pay (8 hours) at the hourly rate of \$1.9575 (or pro rata telegraphers' (telephoners') rate on such Seniority District).

**FINDINGS:** The Third Division of the Adjustment Board finds:

That the dispute was certified to the Third Division of the Adjustment Board ex parte by the complainant party; and

That no hearing thereon has been held, and under date of February 28, 1957, the complainant party addressed a formal communication to the Secretary of the Third Division requesting withdrawal of this case, which request is hereby granted.

**AWARD**

Claim dismissed.
