STATEMENT OF CLAIM: Claim of the General Committee of the Order of Railroad Telegraphers on the New York Central Railroad (Eastern District), that:

1. Carrier violated the terms of the Agreement between the parties when, acting without agreement, it removed from the employes subject to said Agreement, at the agency stations at:
