PARTIES TO DISPUTE:

THE ORDER OF RAILROAD TELEGRAPHERS

**THE NEW YORK CENTRAL RAILROAD, Eastern District
(Except Boston and Albany Division)**

STATEMENT OF CLAIM: Claim of the General Committee of the Order of Railroad Telegraphers on the New York Central Railroad (Eastern District), that:

1. Carrier violated the terms of the Agreement between the parties when, acting without agreement, it removed from the employees subject to said agreement, at the agency station at Norwood, Canton, Potsdam, DeKalb Jct., Gouverneur, Philadelphia, Adams Center, Adams, Pierrepont Manor, Lacona, Richland, Pulaski, Parish, Brewerton, Clay, Morristown, Hammond, Redwood, Castorland, Lowville, Glenfield, Lyons Falls, Boonville, Remsen, Holland Patent, Marcy, Natural Bridge, Benson Mines, Newton Falls, Camden, McConnellsville, Brownville, Neuvelton and Phoenix, the work of checking, rating, preparing waybills, preparing expense bills, and other work in connection with and incidental to, the handling of less-than-carload freight shipments originating at and destined to said stations, and transferred said work to other stations and to employees not subject to the agreement.
2. Carrier shall restore such work to the agency station at Norwood, Canton, Potsdam, DeKalb Jct., Gouverneur, Philadelphia, Adams Center, Adams, Pierrepont Manor, Lacona, Richland, Pulaski, Parish, Brewerton, Clay, Morristown, Hammond, Redwood, Castorland, Lowville, Glenfield, Lyons Falls, Boonville, Remsen, Holland Patent, Marcy, Natural Bridge, Benson Mines, Newton Falls, Camden, McConnellsville, Brownville, Heuvelton and Phoenix, and to the employees subject to the agreement thereat from whom it was unilaterally taken.

FINDINGS: The Third Division of the Adjustment Board finds:

That the dispute was certified to the Third Division of the Adjustment Board ex parte by the complainant party; and

That hearing was waived and under date of August 22, 1961, the parties jointly addressed a formal communication to the Secretary of the Third Division requesting withdrawal of this case, which request is hereby granted.

AWARD

Claim dismissed.
