**BROTHERHOOD OF RAILWAY AND STEAMSHIP CLERKS,
FREIGHT HANDLERS, EXPRESS AND STATION EMPLOYES
JACKSONVILLE TERMINAL COMPANY**

STATEMENT OF CLAIM: Claim of the System Committee of the Brotherhood (GL-5189), that:

1. The Carrier violated the rules of the current working agreement when, effective Sunday, April 16, 1961, all jobs and relief assignments held by Group 1, District 1, clerical employees in Ticket Office — Baggage and Mail Department, were abolished, except position No. 12-51, occupied by C. H. Stephenson, chief clerk, and upon reestablishment of assignments, effective April 16, 1961, the occupants of all jobs including relief assignments, with the exception of the chief clerk's position held by C. H. Stephenson, were required to suspend work to absorb the meal period in violation of the current agreement applicable to the employees of our craft and class.

2. That the Carrier now be required to compensate the following employees for one-half hour overtime daily effective April 16, 1961, and each and every day thereafter until the violation of our agreement is discontinued.
