STATEMENT OF CLAIM: Claim of the System Committee of the Brotherhood (GL-7029)

- (1) Carrier violated the current Clerks' Agreement, at Minden, Louisiana, when Carrier removed traditional work of preparing railroad billing from the Clerk's Contract, and caused or allowed employes of Landa Transport Company, not covered by the clerks' agreement, to prepare necessary railroad billing.
- (2) Carrier shall compensate claimant D. J. Roton, Yard Clerk, Minden, Louisiana, for two (2) hour "Call" on each of the following dates:

OPINION OF BOARD: Since the Scope rule of the Agreement does not cover Motor
Lines employes, no showing has been made by the employes
that the instant work was contracted to rail employes, the work in case was not
under control of Carrier, the work in case was Motor Line's work, and the employes
having failed to show by presentation of competent evidence that the work in dispute was rail work, we will deny the claim.

FINDINGS: The Third Division of the Adjustment Board, upon the whole record and all the evidence, finds and holds:

That the parties waived oral hearing;

That the Carrier and the Employes involved in this dispute are respectively Carrier and Employes within the meaning of the Railway Labor Act, as approved June 21, 1934;

That this Division of the Adjustment Board has jurisdiction over the dispute involved herein; and

That the Agreement was not violated.

AWARD

Claim denied.
