STATEMENT OF CLAIM: Claim of the System **Committee** of the Brotherhood
(**GL-7449**) that:

1. Carrier improperly compensated claimants listed herein for service they were ordered to perform on the dates indicated and that

2. For calling crews, **employees** listed below shall **now** be allowed eight hours' of pay for dates displayed:

- a. **S.** W. Clark, June 8, 1972, called J. W. Randall.
- b. H. A. Griffith, June 10, 16, 25, 26, July 1 and 4, 1972, called J.W. Randall. June 12, 1972 called F. E. **Monninger.**
- c. H. D. Rice, Jr., June 19, 1972 called J.W. Randall.
- d. D. L. **Rupp**, June 11, 1972 called **J.** W. Randall.
- e. M. Small, June 7, 1972, June 20, 1972 and July 2, 1972 called J.W. Randall.
- f. I.L. Wolfe, June 17, 1972, called J.W. Randall.

3.- For delivering mail and print-out sheet **from** Yard Office **to** old Callers' Office, **employees** listed below shall **now** be **allowed** eight hours' of pay for dates displayed:

- a. J. M. Clopper, June 10, 1972
- b. Ii. A. Griffith, June 25, July 1, 2, 3, 4, 7, 8 and 9, 1972.
- c. **H.** D. **Rice**, Jr., June 8, 16, 20, 21, **23**, 27, 28, 30, 1972.
- d. M. Small, June 11, 14, July 1, 3 and 5, 1972.
- e. I. L. Wolfe, July 1 and 7, 1972.

4. For calling **crews-employees** listed below shall **now** be allowed eight hours' pay for dates displayed:

- a. M. Small July 16, 1972, called J. W. **Randall.**
- b. H. D. Rice, Jr., August 2, 1972, called C. O. **Trumpower**,
Called J. W. Randall, August 3, 1972.

5. For delivering mail and print-out sheet from Yard Office to old Callers' Office:

- a. H. D. Rice, Jr., July 4, 1972.
- b. S. W. Clark, August 4, 1972.

6. For calling crews: **employees** listed below shall now be allowed eight hours' of pay for date of January 19, 1973 called J.W. Randall at home.

7. For calling **crews**; employees listed below shall now be allowed eight hours' pay for date of March 15, 1973, called J. W. Randall at his home for **8a Hump 3/15/73**. Claims in **numbers** 6 and 7 **are** for **H. D. Rice, Jr.**

OPINION OF BOARD: In Award No. 18474 (**Rimer**) the Board made a ruling on the principle involved in this claim which is **adverse** to the Employees' position here. That ruling should be followed in this case, and it mandates an award denying this claim.

FINDINGS: The Third Division of the Adjustment Board, upon the whole record **and all** the evidence, finds and holds:

That the parties waived oral hearing;

That the Carrier and the **Employees** involved **in** this **dispute** are respectively Carrier and **Employees** within the meaning of the Railway Labor Act, as approved **June** 21, 1934;

That this Division of the Adjustment Board has **jurisdiction** over the dispute involved herein; and

That the Agreement was not violated.
