STATEMENT OF CLAIM: Claim of the System Committee of the Brotherhood that-

- (a) Carrier violated rules of the Clerks' Agreement at the Cotton Platform, Memphis, Tennessee, when on February 14, 1955, it permitted Will Hubbard, Jr., a Group 3 employe, to perform work secured by the terms of the Agreement to Group 1 employes.
- (b) J. E. Cupples be compensated for wage losses suffered as represented on the dates enumerated herein:

FINDINGS: The Third Division of the Adjustment Board finds:

That the dispute was certified to the Third Division of the Adjustment Board ex parte by the complainant party; and

That no hearing thereon has been held, and under date of October 24, 1956, the complainant party addressed a formal communication to the Secretary of the Third Division requesting withdrawal of this case, which request is hereby granted.

AWARD

Case dismissed.
