STATEMENT OF CLAIM: Claim of the System Committee of the Brotherhood
(GL-9231) that:

(a) The Carrier violated the Clerical Agreement when they did not apply the provisions of the General Agreement and Memorandum Agreement dated September 1, 1949 and arrange to allow Claimant(s), 2 days in excess of 251 Annual Work Days in 1976.

(b) The Carrier should now recompute claimant(s)' pay for the year 1976 and allow him \$... for 2 days pay due to working 2 days in excess of the 251 Annual Work Days in 1976, covering the following claimants:

OPINION OF BOARD: The issue in this claim is identical to that considered in Award 23589. The claim will be sustained on the basis of that Award.

That the Carrier and the Employees involved in this dispute are respectively Carrier and Employees within the meaning of the Railway Labor Act, as approved June 21, 1934;

That this Division of the Adjustment Board has jurisdiction over the dispute involved herein; and

That the Agreement was violated.
