

PARTIES TO DISPUTE: (L. E. Escoto
(The Atchison, Topeka and Santa Fe Railway Company

STATEMENT OF CLAIM: "Claim of L. E. Escoto (#385) that:

(a) Carrier violated the provisions of the current Clerks' Agreement at Topeka, Kansas when it improperly (sic) bulletined position 6128 on March 18, 1986 by inserting the term 'and other duties as may be assigned' or similar words under description of duties, and

(b) Carrier shall be prohibited from using the term 'and other duties as may be assigned' or similar language under description of duties when bulletining a position, and

(c) Claimant Escoto shall now be compensated \$2,713.62 plus \$104.37 for each day after April 29, 1986, and

(d) Claimant Escoto shall now be compensated interest and any other damages and awards deemed proper by this Honorable Board."

FINDINGS:

The Third Division of the Adjustment Board upon the whole record and all the evidence, finds that:

The carrier or carriers and the employe or employees involved in this dispute are respectively carrier and employees within the meaning of the Railway Labor Act as approved June 21, 1934.

This Division of the Adjustment Board has jurisdiction over the dispute involved herein.

Parties to said dispute waived right of appearance at hearing thereon.

As Third Party in Interest, the Transportation Communications Union was advised of the pendency of this dispute and filed a Submission with the Division.

At the outset, we note that the Claimant has other claims for the same period. This Board has consistently held that pyramiding, compounding and duplicating claims cannot be supported. For this reason alone, the Claim warrants dismissal.

Beyond such defect, the facts indicate that no conference was held as required by Rule 47 of the Agreement and the Railway Labor Act. For the reasons set forth in Third Division Award 26749, the Claim must be dismissed.
