DISPUTE:

Claim for Storeman T.J. Sandulak, Thunder Bay, Ontario for payment of wages for March 1 and March 2, 1990.

JOINT STATEMENT OF ISSUE:

On January 30, 1990, Mr. Sandulak was advised by letter from Superintendent of Investigation (Pacific Region) that his position of Security Guard in Winnipeg was to be abolished effective March 1, 1990.

On February 27, 1990, Mr. Sandulak, through his superior, Regional Inspector W. Turchyn, advised Materials (Mr. D.J. Babson, Assistant Manager of Materials, Weston) by computerized mail, that Mr.

Sandulak wished to displace Mr. G. Landry, Line Storeman, Thunder Bay.

On February 27, 1990, Materials acknowledged Mr. Sandulak's intention to displace Mr. Landry and advised Mr. Sandulak, through Mr. Turchyn, that he was qualified to displace and was asked to
