QUESTION  
AT ISSUE:

Claim of the General Committee of the Brotherhood of Railroad Signalmen on the Erie Lackawanna Railway Company that:

(a) Carrier violated Article I, Section 4, of the agreement of February 7, 1965, when it failed and/or refused to properly notify the employees of the Signal Department, New York Division, that operation was suspended and positions were abolished effective at regular starting time Monday, July 17, 1967.

(b) Each and every one of the Signal Department employees adversely affected by an alleged strike on July 17, 1967, be paid eight (8) hours at the straight-time rate of their respective positions for July 17, 1967, account of violation cited in the claim (a) above.


