STATEMENT OF CLAIM:

Claim of the Brotherhood that:

(a) Carrier violated Rule 21, Overtime, of the Scheduled Agreement between the Brotherhood of Maintenance of Way Employees and the Central Vermont Railway effective January 21, 1989, when it failed to properly compensate Claimant R. Tabor for double time, as required.

(b) Carrier should now compensate Claimant an additional 16 hours at Foreman's straight time rate of pay as originally requested and as required by the Rule.

OPINION OF THE BOARD


