## FIND INGS:

The claim before us is in the transmission by other than Operators of Yard Reports.

We believe yard reports are messages the contents of which would have to be recorded by someone at some stage of the proceeding. The facts in the claims before us permit of their separation into two categories: (1) where no operator is involved, and (2) where an operator was involved in their handling.

In all claims where no operator was involved, a sustaining award is required. Our Awards Nos. 40 and 85 must be observed where applicable to any claimant here.

In all claims where an operator participated in the transmission of those reports, a denial award is required.
