STATEMENT OF CLAIM:

Appeal of time held from service (18) days assessed
R. D. Briddell, in connection with being charged with the
unauthorized use of a company vehicle.

Upon the whole record and all the evidence, after hearing,
the Board finds that the parties herein are carrier and
employee within the meaning of the Railway Labor Act, as
amended, and this Board is duly constituted by agreement
under Public law 89-456 and has jurisdiction of the parties
and subject matter.

AWARD: Claim disposed of as follows:

Clearly there is conflicting testimony and Carrier's
charges are not fully supported. Therefore, claimant
shall be compensated for assessed time held out of
service.
