AWARD IN DOCKETS NOS. 29, 30, 36, 37, 45, and 46

STATEMENT "Claim of the System Committee of the Brotherhood that: OF CLAIM:

DOCKET No. 29 - (1) The Carrier violated the effective Agreement by failing to pay holiday pay for Thursday, Thanksgiving Day, November 23, 1961, to B&B employees Denver I. Adams, William P. Dotty, William C. Peregey and Leon P. Kaminski, Baltimore Division.

- (2) That the Carrier should now compensate these employees for one day's pay at their respective pro rata rates account of this violation of the Agreement.
- DOCKET NO. 30 (1) Claim that the Carrier violated the effective Agreement by failing to allow holiday pay for July 4, 1961, to Trackman H. J. Mickey, Pittsburgh East End Division.
- (2) That claimant Trackman H. J. Mickey be now compensated for one day 8 hours at his respective pro rata rate account of this violation of the Agreement.
- DOCKET NO. 36 (1) The Carrier violated the effective Agreement by failing to pay holiday allowance for New Year's Day, January 1, 1962, to Trackmen Archie F. Lighthill and Chelmer W. Sprow of the Chicago Division.
- (2) That claimants Trackmen Lighthill and Sprow now be allowed 8 hours each at their respective pro rata rate of pay account of this violation of the Agreement.
- DOCKET NO. 37 (1) The Carrier violated the effective Agreement by failing to pay Trackman Wayne C. Bridenback, Extra Gang No. 26122, Chicago Division, his holiday pay for January 1, 1962.
- (2) That Trackman Wayne C. Bridenbach be now compensated 8 hours at his pro rata rate of pay, account of this violation of the Agreement.
- DOCKET NO. 45 (1) The Carrier violated the effective Agreement by failing to pay holiday allowance for January 1, 1962, to Carpenter Frank Didiano, New Castle, Pa.
- (2) That claimant Carpenter Frank Didiano be now compensated for 8 hours pay at his respective pro rata rate, account of this violation of the Agreement.

DOCKETS NOS. 29, 30, 36, 37, 45 and 46

S. B. of Adj. No. 488

DOCKET NO. 46 - (1) The Carrier violated the effective Agreement by failing to pay Carpenter Eddie A. Lombardo, Mahoningtown, Pa., Akron Division, for New Year's day, January 1, 1962.

(2) That the claimant, Carpenter Eddie A. Lombardo, be now compensated for 8 hours pay at his respective pro rata rate, account of this violation of the Agreement."

FINDINGS: The claims in these dockets have one thing in common; they are all based on holidays occurring after December 29, 1960, and under our Findings in Dockets Nos. 8 and 9, as well as our subsequent awards, the claims embraced by these dockets will be denied.
